

Merchandise Application, Rules and Information

Thank you for your interest in 3 Days of Heads and Dead October $8^{th} - 10^{th}$ 2021. We have chosen a beautiful Wooded 80+ Acre venue on the Santa Fe River called Ellie Rays RV Resort to host our event located at 3349 NW 110^{th} St. Branford FL 32008. We are expecting anywhere between 500 - 1,500 guests to join in on the festivities. This is a Covid-19 sensitive, limited Capacity event where masks are requested for patrons and required for staff. We are looking for a broad spectrum of misc. goods and services to represent the south east's best festival vendors. The merchandise vendor fee is \$300, which includes 2 weekend camping passes and a 10x10 booth space; each individual 10x10 spot that is needed will be available at the cost of an additional booth cost. The fee is good for one business per booth spot with two staff member. If additional staff members are assisting you, each person must pay an additional \$75 per booth spot. Primitive camping is available to them at that price.

We will notify the selected artists by September 27th, 2021. Upon notification of acceptance we will require payment for your space in full by October 1st, 2021. Once accepted and payment is made no refunds will be available. Your accepted application is a commitment to exhibit.

Vendors are requested to be set up and open for display by 11:00am on Friday. Location is at the vendor coordinator's discretion. Friday, Saturday, Sunday artists are asked to have their booth set up for exhibit during festival hours. Sunday, vendors may pack up any time at their discretion.
